- 2. Introductions of Guests Gregory Mandel, Provost and Richard Souvenir, Vice Provost for Strategic Initiatives, and Interim Vice Provost for Graduate Education
 - a. Provost Mandel thanks FSSC for our commitment and service
 - b. Power Point presentation (this will be sent to us) DEI initiatives; Health and Wellness division; work on developing the Research Office; Gen Ed Review; Meeting later this week with the strategic planning committee. Highlights include:
 - i. Current Strategic Priorities Boundless Access; Educational Value; Thought Leadership; Community Engagement; Reputational Excellence; Committee formed for Strategic Plan
 - ii. **Question:** How many people on this committee **Response**: 40+ people
 - iii. Educational Excellence (this used to have future of work language in it)
 - iv. Foundation for Tomorrow "planning for a sustainable future";
 language change to be clearer on where our values, mission, and vision are
 - v. All this will be updated on the website everything that is being discussed today isn't final and isn't on the website yet
 - vi. **Comment:** Temple's size, breathe, and reputation are the advantages we have; reputation isn't recognized the way it should be
 - vii. **Comment:** there were 40 different strategic initiatives, too many These need to be attractive, help recruitment, and build enrollment; safety, avoid negative P.R., and should focus on 4 pillars (as an example)

- viii. **Response:** It's not down to 4, but are drilling it down further, and enrollment is a big part of that
- ix. Initiatives that are completed or nearly completed: DEI Hub; Mental Health & Wellness; Campus Safety Evaluation; Blue Ribbon Commission; Deans Reviews; Chestnut Hill Hospital
- x. **Question:** Is the Deans Review 360 review? What are the terms?
- xi. **Response:** Yes, and up to 5 years
- xii. Question: Can we have a Deans with a term limit
- xiii. **Response:** It was discussed, but decision was made to have a more thorough review, as we may want to have a Dean with more than 2 terms
- xiv. **Question:** Is there faculty input on the Deans review?
- xv. Response: Yes including mid-year reviews
- xvi. **Question:** For student mental health and wellness, what new initiatives are being put in place?
- xvii. **Response:** Task force, what other schools are doing, looking at the college level; bringing together resources throughout the entire university; ramped up counseling, students get seen within a day or two with many more locations throughout campus
- xviii. **Question:** Balance for students being seen between in person and virtual options
- xix. **Response:** Not sure exact balance, but trying to get students more options and more resources
- xx. **Comment** (FSSC): Linkage and mapping between these initiatives needs to be a priority
- xxi. **Response:** Yes, all will be shown and mapped on the website initiatives are significantly underway
- xxii. **Question:** Student-Athletes are/have a good model of tracking student success; can we have this extra level for regular students as well?
- xxiii. **Response:** Yes continuing to look at several different ways to do this
- xxiv. **Question:** How much can these new initiatives change/revise with the new Presidents vision?
- xxv. **Response:** Need longer term stability with the next President; we don't know when the new president will be named, but we can't wait until then based on where we are; Confident that this will primarily stay the same
- xxvi. <u>www.plan.temple.edu</u> is where everything will go when updated in January
- xxvii. **Comment:** Faculty should have been alerted about the fall break schedule survey before going out
- xxviii. Response: I will find out what happened
- xxix. **Comment:** Mental Health and Wellness faculty should be trained and what to do when things happen with their students
- xxx. Response: Agreed
- xxxi. **Comment:** Wellness Days should apply to everyone (students, faculty, staff, etc.)
- xxxii. **Comment:** If we up the class time to 3 hours a week we can shave 2 weeks off the semester; utilize Qwickly for all classroom attendance for data purposes so it can be used in a good way to help with engagement and retention

xxxiii. **Question:** Al – where are we with that?

xxxiv. Response: We want it for data driven decision making

 - vi. Projection 2118 2030: Northeast -6, South +3, West +1, Mid-West -6%; Texas and Florida have become battle ground starts that many other are trying to target
 - vii. R1 we attract the best faculty in the world that choose to work here; consolidations are happening at community colleges

- viii. **Response:** No. Affordability is not a criteria; Academics is the number 1 criteria for students selecting a school for students and their parents
- ix. **Question:** Can we use political power to help with recruitment (i.e. letter from Mayor of Pittsburgh to students for U of Pitt)

- xii. College Readiness Benchmarks: 60 65% of all HS students are not ready to enter college; how do we build a report infrastructure for these students

- xiv. **Response:** We are focused on the traditional first year students, but a traditional calendar is not going to work; 37% of HS students are saying I am not interested, I will just go work.

- xvi. **Response:** We are in a boiler room, we need everyone on deck, and to help support this. Faculty needs to get involved; I have not missed a target ever since 2012.
