Call to Order

- 2. Introduction of Guests: Jeff Doshna (TYL) and Steve Newman (CLA), Discussion of RCM white paper
 - a. At the October 23, 2024 Representative Faculty Senate meeting with the Board of Trustees, faculty raised the issue of RCM. Trustee Morgan invited us to write a white paper on the topic.
 - b. Guests and members of the FSSC discussed the pros and cons of taking on such a project—would administrative decision makers read the product?
 - c. Several topics were discussed as probable components of a white paper:
 - i. Receive a standard data set that is useful (factual)
 - ii. Role of faculty in reviewing RCM decisions/allocations
 - iii. Alternatives to RCM, such as performance-based budgeting
 - iv. Multi-year budgets
 - v. Improve transparency about the use of vendors and spending decisions
 - vi. Talk with other colleagues at institutions that abandoned RCM, especially the University of Illinois–Chicago
- 3. President's Report: Shohreh Amini
 - a. The Executive Committee of the Faculty Senate will be meeting with Provost Mandel before the end of the semester.
 - b. Provost plans to attend the December 12th meeting of the University Faculty Senate with President Fry
 - i. Discussed setting an agenda of issues for the meeting, such as:
 - 1. RCM

- 3. Temple's football program
- 4. Term limits for Deans
- c. President Fry is scheduled to attend a meeting of the FSSC. His visit will be on February 4, 2025.
- d. Dan Berman will speak to the FSSC about student retention. He would be accompanied by Jodi Bailey to further discuss student success. Their presentation will be separate from Jose Aviles' presentation about recruitment.
- e. Athletic Director Art Johnson met on Zoom with Shohreh Amini to discuss some details about the December 3rd meeting we have with Liz Taylor, our NCAA liaison
- f. Michael Gebhardt, Secretary to the Board of Trustees, will talk to FSSC early in the spring term.
