- -biggest initiative is a needs assessment
- -task force about interdisciplinary programs creating MOUs
- -looking at 4+1 programs, accelerated programs, etc.
- -enrollment management advances moving everyone over to Slate from Recruit
- -international recruitment we partner with QS
- -funding for master's students is up to schools and colleges themselves. International students respond better to "scholarship" than to "waiver"
- -updating policies and procedures
- -launching more professional development events
- programs above available to post-doctoral fellows as well
